- It is Wayne's belief that legal action should be taken against the KYCC to have the current KYCC board removed. He voiced some very good reasons including accountability for the handling of funds.
- If the KYCC board does not accept our revised lease, an alternative location for the library could be on property owned by the city at the new ballpark with possibly a city complex.

C. Sewer Repairs

- Made the front page of the Krum newspaper. Repairs are delayed due to some disagreements and changes. The library is currently does not have working bathrooms.
- Safety issue the hole dug for the sewer replacement is open and children are playing
 on the dirt piles above the hole. Michelle will write a letter to the city and attach
 pictures. George will check out the delay in the sewer repair project.
